NOTES TO THE CONDUCTOR

This catchy tune from the band BTS occupied the #1 spot for many weeks in 2021. The dotted-eighth/sixteenth-tied-to-an-eighth/eighth rhythm is utilized throughout the arrangement. Introduce or reinforce this rhythm in your warmup routine, stressing rhythmic accuracy and ensemble precision.

The staccato quarter notes should be played in the middle of the bow on the string with a martelé bow stroke. The staccato eighth notes should be played on the string as well, but in the lower third of the bow.

There are easy drumset and percussion parts included—both are totally optional. The 1st violin part in measures 34–37 can be performed either as a solo or by the section.
